PROSPECTUS FOR ADMISSION INTO B.Sc. NURSING 4 YDC COURSE FOR 2022-23

1. REGULATIONS:

- A) These Regulations are applicable for admission into Competent Authority Quota Seats in Government and Private Nursing colleges.
- B) All the Candidates shall fulfill the regulations for admission into B.Sc.,(N) 4 years Degree Course for admission into Competent Authority Seats.
- C). The candidates are advised to take a print out of the prospectus / instructions to fill the application form from the website www.knruhs.telangana.gov.in before proceeding to fill the application form.
- D). The Seat matrix for Competent Authority Quota seats into B.Sc Nursing 4 YDC Course at Government and Private Colleges for academic year 2022-2023 will be displayed in the KNRUHS website before exercising web options for counseling.
- E). Tuition Fee shall be as notified by the State Government.
- F). In case any new BSc Nursing 4 YDC seats/new colleges are permitted by Authorities for the Academic Year 2022-2023, those seats will also be filled up. No further notification will be issued.

2. Eligibility (As per the G.O.Rt.No.1095, HM &FW Dept., dated 02.09.2013)

- i. The candidates should be citizens of India and should satisfy the local or non-local status in Telangana /Andhra Pradesh as laid down in Andhra Pradesh Educational Institutions (Regulations of admissions) order, 1974 and the selection will be done as per the procedure laid down in the G.O.P.No.646, dated 10-07-1979 as amended in G.O.Ms.No.42, Higher Education (EC2), dated 18-05-2009.

ii. Candidates have to apply online and upload the original certificates in response to notification to be issued by KNRUHS. The merit rank notified after verification of certificates by KNR University of Health Sciences, shall be the basis for selection into B.Sc.,(N) 4Ydc course into Competent Authority Quota seats.

iii. EDUCATIONAL QUALIFICATIONS:

a. Candidates seeking admission into **B.Sc.,(Nursing) 4 YDC** Course should have passed 2 years Intermediate Examination (10 + 2 pattern) with 45% aggregate of marks in Science (Biology, Physics ,Chemistry) and English is compulsory subject in 10+2.

Or

b. Any other examination of (10 + 2 pattern) from recognized Board under AISSCE / CBSE/ ICSE / SSCE / HSCE / NIOS / TOSS of other equivalent Board with Biology, Physics and Chemistry recognized as equivalent by Board of Intermediate Education, Telangana state.

Or

Intermediate (10+2) Vocational with Bridge course with Biology and Physical Sciences.

c. Those who belong to SC/ST and BC categories are eligible with 40% aggregate marks in the science group subjects (Biology and Physical Sciences). English is compulsory subject as per the norms of the Indian Nursing Council, New Delhi vide letter No.F.No.1-2/2014-INC and vide circular No.F.No.1-6/2016 –INC Dated:21-09-2016.

d. Candidates possessing qualification of the University / Board or an institution outside the State should produce a certificate of equivalence from the Board of Intermediate Education of Telangana, Hyderabad to the effect that the qualification possessed is equivalent to or higher than Intermediate examination conducted by the Board of Intermediate Education of Telangana of BPC group.

Note: The Intermediate (TOSS) Candidates who have qualified in the year 2021 shall be treated as having minimum required percentage of marks at Intermediate level as prescribed by concerned authorities/Deemed to be Universities/other Private Universities recognized by UGC. vide reference: G.O.Ms.No.17 Dated:29.10.2020 and G.O.Ms.No.19 Dated:29.06.2021.

AGE: Candidates should have completed the age of 17 years as on 31st December 2022.

Note:

- i. Age shall be calculated on the basis of date of birth as indicated in the Secondary School Certificate examination or equivalent examination.
- ii. No request for relaxation of age of a candidate shall be permitted.
- iii. Candidates born on or after 02-01-2006 are not eligible
- iv. Student shall be medically fit.

3. RESERVATION OF SEATS FOR SCHEDULED CASTES & SCHEDULED TRIBES.

1. Out of the total seats under Competent Authority Quota 15% are reserved for SC category candidates and 6% are reserved for ST category candidates. If any seat reserved for the Scheduled Tribes is not filled up they will be open to the candidates belonging to Scheduled Castes and Vice-Versa.
2. If the candidates from Scheduled Castes & Scheduled Tribes are not available these reserved seats shall be converted to open category seats and allotted on the basis of merit.
3. Reservation for the Scheduled Castes and Scheduled Tribes shall be considered for castes which are notified in the SC/ST caste list as per the Telangana Government orders only.

4. RESERVATION FOR BC CANDIDATES:

- a) 29% of the total seats under Competent Authority Quota shall be reserved for candidates belonging to Backward Classes and shall be allotted among the five sub - groups of Back Ward Classes as follows:-

BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%.

- b) Candidates who belong to the notified Backward Class castes of the States of Telangana which are listed in the Telangana State Government orders shall be considered for reservations.
- i. If eligible candidates belonging to Backward Classes of a particular sub-group are not available, the left over seats can be allotted to the candidates of next sub- group ie., BC A to BC B to BC C to BC D to BC E.
 - ii. If eligible candidates of Back Ward Classes category are not available for the 29% seats reserved for them, the left over seats shall be converted to Open category seats and shall be allotted as open category seats on the basis of merit.
- c) While calculating the number of seats in the sub-groups if the total number of seats falls short of or exceeds 29%, it shall be limited to 29% by adding or eliminating the candidates on the basis of merit in the sub- groups in which the fractions were rounded to nearest figure.

CERTIFICATION OF CASTE:

- a) Scheduled Caste, Scheduled Tribe and Backward class candidates shall in support of their claim, have to furnish Permanent caste certificate issued by the Competent Authority of State Government.
- b) The social status of the candidates who have applied for the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Classes shall be scrutinized as per the rules notified by the concerned department officials of Government of Telangana.
- c) The decision of the verification officer deputed by the Director / Commissioner of BC Welfare, SC Welfare and ST Welfare from the Government of Telangana is final in all respects.
- d) Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to Telangana State for castes which are notified as per the Telangana Government orders will be considered against the reserved seats.

5. RESERVATION FOR WOMEN CANDIDATES:

33 1/3% of seats are guaranteed for women candidates in each category i.e., Open category, Scheduled Castes, Scheduled Tribe, Backward Classes Group A, B, C, D and E. This regulation of guarantee shall not be applicable if women candidates selected on merit in each category form 33 1/3% or more of the seats therein. When the number of women candidates falls short of this percentage, it would be made up by replacing the last selected male candidates by women candidates in that category.

6. RESERVATION UNDER PWD CATEGORY:

5% of total seats in each categories shall be reserved for the Persons With Disabilities (PWD) i.e., OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E categories as per Government of India guidelines.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board constituted by the University, comprising professors from Government Medical colleges from relevant specialties. The decision of the Medical Board constituted by the University is final.

7. RESERVATION FOR LOCAL CANDIDATES:

- i) 85% of the seats shall be reserved for local candidates and 15% shall be unreserved seats.

7.1. DEFINITION OF LOCAL AREAS

a) The part of the state comprising the districts of Adilabad, Hyderabad, (including twin cities), RangaReddy, Khammam, Karimnagar, Medak, Mahaboobnagar, Nalgonda, Nizamabad and Warangal shall be regarded as the Osmania University Area.

b) The part of the State comprising the districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as Andhra University Area.

c) The part of the State comprising the districts of Anantapur, Kurnool, Chittoor, Cuddapah and Nellore shall be regarded as Sri Venkateswara University Area.

7.2 DEFINITION OF LOCAL CANDIDATES

7.2.1. A candidate for admission shall be regarded as a local candidate in relation to a local area.

a) If he/she has studied in educational institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared in the relevant Qualifying Examination.

b) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared for Intermediate Examination, he/she has not studied in any educational institution, if has resided in the local area for a period of not less than four years immediately preceding the date of commencement of relevant examination in which he/she appeared, or as the case may be, first appeared then he/she becomes a local candidate.

7.2.2 A candidate for admission to the course who is not regarded as a local candidate under sub regulation 7.2.1 above in relation to any local area shall

a) If he/she has studied in Educational Institutions in the State for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared for the relevant qualifying examination be regarded as a local candidate in relation to.

i) Such local area where he/she has studied for the maximum period out of said period of seven years.

ii) where the periods of his/her equal, such local area where periods study in two or more local areas are he/she has studied last in such equal.

b) If, during the whole or any part of seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in the

educational institutions in any local area, but has resided in the State during the whole of the said period of seven years, be regarded as local candidate in relation to

- i) Such local area where he/she has resided for the maximum period out of the said period of seven years,
- ii) Where the periods of his/her residence in two or more local areas are equal such local area where he/she has resided last in such equal periods

Explanation–For purpose of this Sub regulation.

a) “Educational Institution” means a college, a school imparting education upto and inclusive of tenth class, or other institutions by whatever name called whether managed by Government, Private body, local authority or University and carrying on the activity of imparting education therein whether technical or otherwise and includes a Polytechnic, Industrial training Institute and a Teachers Training Institute but does not include a Tutorial Institution.

b) Relevant qualifying examination for admission in to B.Sc., Nursing 4 year’s degree course of study means a pass in the examination, which is the minimum educational qualification for admission to such course of study.

Note: The relevant qualifying examination for admission into B.Sc., Nursing degree course being Intermediate or its equivalent examination, the question whether candidate is a local candidate or not will be determined with reference to the first appearance in the Intermediate examination or equivalent examination even in the case of an applicant is possessing B.Sc or M.Sc. Degree.

a) In reckoning the consecutive academic years during which a candidate has studied, any period of interruption of his/her study by reason of her failure to pass any examination, and

b) Any period of his/her study in a State-wide University or Statewide Educational Institution shall be disregarded.

c) The question whether any candidate for admission to any course of Study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of her parent or guardian.]

7.3 While determining the number of seats to be reserved in favour of local candidates under regulation 7(i) any fraction of a seat shall be counted as one provided there shall be one Unreserved Seat.

7.4 If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled in as if it has not been reserved.

7.5 The applicants who claim to be local candidates with reference to regulation 7.2.1 7.2.1. a) shall produce evidence in the form of study certificate/certificates issued by the Heads of Educational Institution/Institutions concerned, indicating the details of the year or years in which the candidate has studied in educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic years in which he/she appeared or as the case may be, first appeared for the Intermediate examination or its equivalent.

Those who do not qualify as local candidates under sub regulation 7.2.1 (a) and 7.2.1 (b) but claim to qualify by virtue of residence under regulation above shall produce a certificate issued by an officer of the Revenue Department not below the rank of a Mandal Revenue Officer in the form annexed in G.O.Ms.No.628 Education, dated 25th July,1974,(appended to the application)

7.6 Applicants who claim to be local Candidates under regulation 7.2.2 (a) above shall produce evidence in the form of study certificate issued by the heads of the Educational Institution/Institutions concerned indicating the details of the year or years in which the candidate has studied in the respective educational Institutions for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared, or as the case may be first appeared for the Intermediate Examination or its equivalent. Those who do not qualify as local candidate under the regulation 7.2.2 (a) but claim to qualify by virtue of residence under regulation 7.2.2 (b) shall produce a certificate of residence issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer in the form similar to that Annexed to G.O.Ms.No.628, Education, dated 25th July 1974 with necessary modifications (appended to the application).

7.8 The following categories of candidates are eligible to apply for admission to the 15% of Unreserved seats:

All candidates defined under regulation 7.2

Candidates who have resided in the State for a total period of ten years excluding period of study outside the State or either of whose parents have resided in the State for a period of ten years excluding periods of Employment outside the State (Certificate to the effect from a Revenue Official not below the rank of Mandal Revenue Officer from where the candidate is claiming eligibility should be enclosed).

Candidates who are children of parents who are in the employment of this state or Central Government, Public Sector Corporations, Local Bodies, Universities and other similar quasi-public Institutions within the State. (Certificate from the Head of the Institution / Department should be enclosed).

Candidates who are spouses of those in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, University and Educational Institutions recognized by the Government, a University or other competent authority and similar other quasi Government institutions within the state. (Certificate from the Head of Institution/Department should be enclosed).

8. ONLINE APPLICATIONS:-

The on-line application form for determining merit position for Competent Authority Quota seats will be available on the website <https://tsparamed.tsche.in> from 9.00 AM on 23-09-2022 upto 06.00 PM. on 03-10-2022.

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://www.knruhs.telangana.gov.in/> or from <https://tsparamed.tsche.in> before proceeding to fill the application form.

The candidate should fill the online application form available in the Website with the data required for through computer or Laptop with data connection. The online application form can be filled through any computer with internet connection or Laptop. The candidate is advised to fill the online application form after going

through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) and ready to enter his/her correct data and upload the photo, signature and original certificates, after the payment of application fee through Online.

8.1 Registration and Processing Fee:

The Registration and Processing fee Rs.2500/- (Bank transaction charges extra) for OC & BC candidates and Rs.2000/- (Bank transaction charges extra) for SC/ST candidates shall be paid online through Debit card / Credit card or Net Banking.**

****Registration and Processing fee once paid will not be refunded or adjusted to a further date.**

The candidates are advised to download and read the Prospectus of the course to verify for eligibility under local/non local category.

9. CATEGORIZATION OF SEATS:

- i. As per G.O.Ms.NO.330, HM&FW(K1) Department,dt.11-11-2011, in Private institutions Sixty percent (60%) of the total number of seats shall be filled as Competent Authority Quota seats by university.
- ii. Forty percent (40%) seats shall be filled as Management Quota seats by the Managements of Private Colleges.
- iii. In respect of the Government colleges 100% Nursing seats shall be Competent Authority Quota, will be filled by the University.

10. MERIT LIST:

THE PROVISIONAL FINAL MERIT POSITION OF APPLIED CANDIDATES FOR COMPETENT AUTHORITY QUOTA SEATS SHALL BE NOTIFIED AFTER VERIFICATION OF UPLOADED CERTIFICATES.

The provisional Final merit list shall be prepared by the Admission Committee appointed by University subject to these regulations.

The criteria for preparation of merit list (B.Sc. NURSING COURSE)

- a. Total Percentage of marks obtained in Botany, Zoology, Physics, Chemistry in the qualifying examination upto two decimal places.
- b. The candidates who qualify under compartmental system shall be placed in the merit list after the candidates who passed in a single attempt.
- c. In case of equality of marks, Age shall be taken into consideration and the older candidates shall be given higher place in the Merit List.
- d. In case of tie in equality of marks and age, the aggregate percentage of marks in all subjects of the qualifying examination up to two decimal places.

11. PROCEDURE OF SELECTION:

Selection will be made by the Admission Committee appointed by Vice-Chancellor, KNR University of Health Sciences based on the web-options given by the candidates and their merit.

- a. Selections shall be made local area wise as per the procedure prescribed in Annexure-III of G.O.P.No.646, Education (W) Dept. dated 10-7-1979, as amended in G.O.Ms.No.42, Higher Education (EC2) Dept., dated: 18-05-2009.
- b. The Selection Committee will allot a candidate seat to the Nursing College based on their web-options and merit.
- c. Selected candidates will receive the allotment message on the registered mobile number after allotment of seat. Candidates are directed to check the website for allotment list after exercising web-options
- d. Selected candidates have to download the allotment order on payment of **University fee of Rs. 6,000/- (Rupees Six thousand only)** besides payment

gateway charges through payment gateway and report to the Principal of concerned college along with all Original Certificates and pay the tuition fee as notified by Government at the college to complete the admission process.

12. ADMISSION RULES

- a. The letter of allotment for admission of selected candidate will have to be downloaded from website after payment of University fee by payment gateway.
 - b. The candidate should submit the print-out of the filled-in Online application form, allotment order and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final verification by the Admission Committee constituted at each college. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
13.
