### **REGULATIONS FOR ADMISSION INTO BAMS / BHMS, BNYS AND BUMS COURSES FOR THE ACADEMIC YEAR 2022-23 UNDER COMPETENT AUTHORITY QUOTA**

#### **REGULATIONS:**

The following are the Regulations for admission into **BAMS / BHMS / BNYS AND BUMS** Courses in all the AYUSH Colleges affiliated to KNRUHS for the academic year 2022-23 under Competent Authority Quota.

#### **1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA:**

Total number of seats for the academic year 2022-23 in AYUSH Courses in Government AYUSH Colleges (after exclusion of 15% seats transferred to All India Quota and to Government of India) and Category 'A' seats (after exclusion of 15% seats transferred to All India Quota) in Private Un- aided AYUSH Colleges affiliated to KNR University of Health Sciences , Warangal shall be notified on KNRUHS website before counseling.

1.1 In case any **BAMS / BHMS / BNYS AND BUMS** seats are permitted by NCISM /NCH in colleges affiliated to the University for the Academic Year 2022-23, those seats also will be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.

2 **Tuition Fee** will be as notified by the Government of Telangana.

3 **Age:** Candidates should have completed the age of 17 years as on **31-12-2022**. There is no upper age limit for admission to ASU&H-UG Courses.

**NOTE:** 1) Age shall be calculated on the basis of the date of birth as indicated in S.S.C. Examination or its equivalent examination.

2) A person born on 1st January of a year will complete one year on 31<sup>st</sup> December of the same year.

3) Relaxation of minimum age criteria prescribed is not permitted. Upper age limit is relaxable by 5 years for SC/ST /BC /PWD Candidates

4) Candidates should have completed 17 years of age as on 31-12-2022 born on or after 02-01-2006 are not eligible for admission as they have not completed 17 years of age.

5) The candidates should secure marks of cutoff scores and above in National Eligibility- cum- Entrance Test NEET UG -2022 , conducted by CBSE, New Delhi as per section (10) of Indian Medical Council Act, 1956.

### **4 ELIGIBILITY FOR ADMISSION INTO BAMS/ BHMS/ BNYS and BUMS:**

- a) THE CANDIDATES WHO FULFIL THE FOLLOWING CRITERIA SHALL APPLY FOR ADMISSION INTO **BAMS / BHMS / BNYS and BUMS** COURSES ONLINE FOR COMPETENT AUTHORITY QUOTA SEATS IN COLLEGES AFFILIATED TO KALOJI NARAYANA RAO UNIVERSITY OF HEALTH SCIENCES, WARANGAL.
- b) The candidate should be an Indian National and should satisfy the Local or Non- local status in Telangana (Residence requirement) as laid down in Andhra Pradesh Education Institutions (Regulations of Admissions) Order, 1974. Selection will be done as per Government orders and University, NCH and NCISM Regulations.
- c) **QUALIFICATIONS FOR ADMISSION** into BAMS / BHMS / BNYS The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / and English.
  - OC candidates including candidates seeking EWS reservation should obtain not less than 50% marks in science subjects.
  - BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
  - OC PWD candidates should obtain not less than 45% marks in science subjects.
- d) **QUALIFICATIONS FOR ADMISSION INTO BUMS COURSE AS PER REGULATIONS OF CENTRAL COUNCIL OF INDIAN MEDICINE.**

**Admissions to Kamil-E-TIB-Wa-Jarahat course:** A candidate seeking admission to main Kamil-E-Tib-Wa-Jarahat (Bachelor of Unani Medicine and Surgery – B.U.M.S.) Course must have passed.

- i. Intermediate 10+2 or equivalent examination with 50% aggregate marks in the subjects of Physics, Chemistry, Biology and English individually for general Category and 40% marks in the case of the Scheduled Castes, Scheduled Tribes and other Backward classes. OC PWD candidates should obtain not less than 45% marks in science subjects.

and

- ii. The candidate should have passed 10th/Intermediate with Urdu or Arabic or Persian language as a subject or clear the test of Urdu of 10th/Intermediate (wherever there is provision to conduct of such test) in the entrance examination conducted by the University or Board or Registered Society or Association authorized by the Government to conduct such examination

(or)

The Pre - Tib examination of one year duration

**Note :** Candidates possessing qualification of the University/Board or an institution outside the State should enclose a certificate of equivalence from Board of Intermediate Education of Telangana to the effect that the qualification possessed is equivalent to or higher than Intermediate examination with subjects of Biology, Physics, Chemistry and English conducted by the Board of Intermediate Education of Telangana.

## **5.0 ELIGIBILITY CONDITIONS IN RESPECT OF CANDIDATES WHOSE DOMICILE OF TELANGANA /ANDHRA PRADESH**

**5.1** The candidate shall satisfy Local / Non local status as per GO.No.646 Education (W1) department dated 10-07-1979 and Presidential order. The procedure indicated in the above G.O for selection of candidates as amended in G.O.Ms.No.42, Higher Education (EC2) Dept., dated 18-05-2009, G. O. Ms. No.170, HM&FW (E1) Dept. subsequent amendments and relevant Hon'ble High Court and Hon'ble Supreme Court orders shall be followed

**The Non local candidates are eligible for 15% unreserved seats only. The local candidates are also eligible for 15% unreserved seats along with 85% seats reserved for local area.**

**5.2** The verification and registration fee once paid will not be refunded or adjusted to a future date. Therefore candidates are advised to check eligibility conditions thoroughly before applying on-line for determining state merit position in respective categories for Competent Authority seats.

### **5.3 RESERVATION IN FAVOUR OF THE LOCAL CANDIDATES**

**5.3.1** Admission to 85% of the seats shall be reserved in favour of the local candidates in relation to the local area as provided in A.P. Educational Institutions (Regulation of Admission) order, 1974 for Non- State-Wide courses as given in Annexure-III of GO (P) No. 646, Edn. (W1) Department, dt.10-7-1979.

### 5.3.2 State-wide COURSES (BUMS, BNYS):

Admission into State wide colleges shall be regulated as per the provisions in the A.P. Educational Institutions (Regulation of Admission) Order, 1974 for State-Wide courses as given in Annexure-IV of GO (P) No. 646, Education (W1) Department, dt.10-7-1979.

### 5.4 LOCAL AREA:

5.4.1 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasham shall be regarded as the local area for the purposes of admission to the Andhra University, \*(Nagarjuna University) and to any other education institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

5.4.2 The part of the State comprising the Districts of Adilabad, Hyderabad, Rangareddy, Karimnagar, Khammam, Mahaboobnagar, Medak, Nalgonda, Nizamabad and Warangal shall be regarded as local area for the purposes of admission to the Osmania University, \*(the Kakatiya University) and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

5.4.3 The part of the State comprising the Districts of Ananthapur, Kadapa, Kurnool, Chittoor and Nellore shall be regarded as local area for the purposes of admission to Sri Venkateswara University and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

5.4.4 A Candidate for admission shall be regarded as local candidate in relation to a local area.

i) If he/she studied in an Educational Institution or Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in relevant qualifying examination.

or

ii) Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which he/she appeared or as the case may be first appeared.

or

5.4.5 A candidate who is not regarded as a local candidate under sub-regulation (5.4.4) above in relation to any local area shall

- i) If he/she has studied in educational institutions in the State for a period of not less than 7 consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as local candidate in relation to:
  - a) Such local area where he/she has studied for the maximum period out of the said period of 7 years.
  - b) Where the period of his/her study in two or more local areas are equal, such local area where he/she has last studied in such equal periods

or

- ii) If during the whole or any part of the seven consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for relevant qualifying examination, he/she has not studied in the educational institution in any local area, but he/she has resided in the State during the whole of the said period of 7 years be regarded as a local candidate in relation to
  - a) Such local area where he/she has resided for the maximum period out of the said period of 7 years.

or

- b) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

N.B.: Relevant certificates must be uploaded along with the application in respect of their claim. In respect of proof of 10 years residence, the certificate should be obtained from the Revenue Authorities not below the rank of Mandal Revenue Officer/Tahsildar.

**NOTE: Candidates from other states are not eligible for Competent Authority Quota**

## **6. RESERVATIONS:**

### **A. RESERVATION FOR SCHEDULED CASTES (S.C.) AND SCHEDULED TRIBES (S.T.):**

Out of the seats available under Competent Authority Quota 15% seats shall be reserved for candidates belonging to Scheduled Castes.

10% of seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Tribes as per G.O.Ms.No. 33, Tribal Welfare Department, dated.30.09.2022.

- 6.1 In the event that if any seats reserved for S.T. not being filled up, they will be thrown open to the candidates belonging to the Scheduled Castes and vice-versa.
- 6.2 In the event of the candidates from the SC and ST are not being available, these seats shall be allotted to the candidates under open category.
- 6.3 Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Telangana and Andhra Pradesh, for castes which are specified by the Govt. of Telangana from time to time shall be considered for reservations.

## **B. RESERVATION FOR BACKWARD CLASSES:**

29% of the available seats for admission by the University for **BAMS / BHMS / BNYS AND BUMS** shall be reserved for candidates belonging to Backward Classes as follows:

- BC-A -7%, BC-B-10%, BC-C-1%, BC-D-7% & BC-E\*-4% as per the G.O.Ms.No.1793, Education, dt.23.09.1970 and G.O.Ms.No.23, Backward Classes Welfare (C2), dated. 07.07.2007 and G.O.Ms.No.231, Health Medical and Family Welfare (E1) Department, dated 11.07.2007.and G.O.Ms.NO. 114 HM&FW (C1) Dept. Dated: 05-07-2017 and subsequent amendments.
- Candidates of the Backward Classes belonging to the State of Telangana and AP shall be considered for BC reservations for BC castes , which are notified by the Govt. of Telangana as Backward classes from time to time
- If qualified candidates belonging to Back Ward Class of particular group are not available, the left over seats can be adjusted for the candidates of next group. If qualified candidates belonging to Back Ward Classes are not available to fill up the 29% seats reserved for them, the left over seats shall be treated as Open Category seats and shall be filled up with candidates by merit.

## **C. SOCIAL STATUS CERTIFICATE:**

The candidates belonging to Scheduled Castes, Scheduled Tribes and Backward Classes shall furnish a latest certificate in the prescribed proforma issued by competent authority in support of their claims. The social status of Schedule Castes, Scheduled Tribes and Backward Classes candidates shall be Scrutinized in terms of G.O.M.s.No.58, SW (J) Dept. Dt. 12-05-1997 and subsequent amendments and orders of Hon'ble High Court. The candidates are informed that they will not be considered for the caste claimed by them without the prescribed permanent caste certificate issued by the competent authority of Government of Telangana.

**No candidate seeking reservation for admission under the above categories be allowed to participate in the Counseling for admission unless candidate produces the Integrated Community Certificate prescribed by the Government and issued by the Revenue Authorities in the Government (Vide G.O.Ms.No. 58, Social Welfare (J) Department, dated. 12-05-1997).**

**Note :-** The Social Reservation provided for SCs, ST's and BC's in the ratio of 15% , 10% and 29% respectively shall be vertical reservations.

#### **D. RESERVATION FOR EWS CATEGORY :**

10% of total seats in specified Government Ayush Colleges ( Specified for EWS Reservation implementation) are reserved for Economically Weaker Section ( EWS ) Category candidates who are not covered under the existing scheme of reservation for SC,ST & Socially and Educationally Backward Classes. These reservations will be implemented from seats sanctioned for implementation of EWS reservations by Ministry of Ayush, Government of India .

Open category candidates claiming reservation under EWS Category shall obtain the relevant EWS certificate for reservation under Economically Weaker Section issued by Tahsildars who is the competent Authority in state of Telangana for issue of EWS Certificate.

#### **7. RESERVATION FOR WOMEN CANDIDATES**

33 1/3% of seats shall be reserved for women candidates in each category; This regulation of guarantee shall not be applicable if women candidates are selected on merit in each category from 33 1/3% or more of the seats therein.

#### **8. SPECIAL CATEGORY RESERVATIONS UNDER THE CATEGORIES OF CAP, NCC , PERSONS WITH DISABILITY (PWD).**

Seats shall be reserved in each course and in each category for the following to the extent indicated against them:

1	CAP (Army)	:	1 %
2	National Cadet Corps (NCC)	:	1 %
3	Persons With Disabilities (PWD)	:	5 %

#### **NOTE:**

- i) . Reservation under CAP Category: 1% for children of Ex-Service men & Serving personnel of 3 wings of defense service viz., Army, Navy & Air-Force subject to the condition that the said Ex- servicemen etc., who are domicile of Telangana based on the Permanent address / Home town declared by them while joining service and as recorded in their service register.

(Vide G.O.M.S.No.66 HM&FW (C1) Dept. Dated: 29-07-2015).

- ii) The guidelines of Govt. of India and regulations of NCH, NCISM/NMC shall be observed in making admissions of Persons With Disabilities (PWD) candidates.

The Medical Board constituted by the University as per G. O. MS. No 114 HM&FW (C1) Dated:05-7-2017 will assess the percentage of disability as per Medical Council of India regulations. Candidates claiming reservation under PWD quota should present themselves before the Board constituted by University for evaluation of PWD percentage and confirmation of eligibility. The decision of Medical Board specially constituted for this purpose is final and binding on the candidates. The schedule for evaluation by Medical Board will be displayed on KNRUHS website.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board comprising of at least one Expert/Specialist from the specialty of Orthopedics, Department of Medicine, Neurology, Hematology of the rank of Professor constituted by KNR UHS, Warangal.

- iii) The candidate who claim for admission under Persons with Disabilities (PWD) category shall mention in the online application as applying under PWD category and have to appear before Medical Board to be constituted for the purpose by the university as per the schedule to be notified by the university for eligibility under PWD status.

- 9.2.** The candidate should fill the online application form available in the Website with the data required for through computer. The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the necessary certificates, photo and signature after the payment of application fee through Online.




