### MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2022-23

#### **NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SECOND PHASE COUNSELING FOR MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA INTO AFFILIATED GOVERNMENT, PRIVATE UN-AIDED MINORITY/NON- MINORITY MEDICAL COLLEGES.**

In continuation to this office notifications dated: 10.10.2022, 23.10.2022 and 28-10-2022 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of 2<sup>nd</sup> phase of web based counseling for allotment vacant seats after first phase of counseling and permitted seats in Government Medical College, Mancherial, TRR and Mahavir Institutes of Medical Sciences for MBBS course under Competent Authority Quota for 2022-23 in Government, Private un-aided Minority/Non- Minority Medical Colleges in the State of Telangana.

Candidates whose names are notified in the provisional final merit list of MBBS/BDS Admissions on the KNRUHS website are eligible to exercise web - options online from computer with internet connection with the following conditions.

1. The Candidates who were allotted seats in the first phase of counseling and have not reported/discontinued the course at the respective college are not eligible for exercising options.
2. Candidates who have not exercised web options in the first phase of counseling are also not eligible to exercise web options.
3. Candidates who are admitted after the second phase of the counselings in All India Quota Counselling are not eligible to exercise web options.
4. The candidates who were allotted MBBS seats in the first phase of counseling and joined the course are also eligible to exercise web options and are informed to exercise web options.
5. Candidates are not permitted to withdraw/discontinue from the course after allotment in second phase of counseling. Hence first phase admitted candidates are advised to take a calculated decision of continuing in Second phase of counseling as they will not be permitted to resign from 2nd phase allotted seat. They will also not be allowed to participate in any further counselings of AIQ/State counselings after joining in Second phase as per Hon'ble Supreme Court orders.

All the eligible candidates whose names are displayed in the Provisional final merit list including PWD, NCC, CAP categories and EWS quota candidates on KNRUHS website can exercise web options for admission into MBBS seats from 11.00 A.M. on 26.11.2022 to 1.00 P.M. on 28.11.2022 through website <https://tsmedadm.tsche.in/>

For eligibility criteria and regulations refer to notifications dated: 10.10.2022.

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs. 12,000/- for MBBS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter. **Candidates who have already paid university fee in the 1st phase need not pay again**

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in GO Ms No:5, HM& FW (C1) Department, .Dated:27. 01.2022 (notified on KNRUHS web site)

**NOTE:**

1. The details of seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for MBBS seats in all Medical colleges affiliated to KNRUHS through <https://tsmedadm.tsche.in/>.
2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, relevant Hon'ble High Court/Supreme court orders and University regulations,
3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options for the regulations.
4. Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.

**IMPORTANT INSTRUCTIONS TO THE CANDIDATES:**

- 1) Eligible NEET-UG-2022 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for MBBS seats in Medical colleges as per their interest and priority through

<https://tsmedadm.tsche.in/> from computer with internet connection.

- 2) Candidates are advised to go through the prospectus for the regulations for MBBS course of KNRUHS, available on website before exercising web-options.
- 3) Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidates eligibility.
- 4) **Candidates are advised to exercise web options for MBBS seats in all colleges in which they are interested to join irrespective of available seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counseling. If candidates are not interested to join in any subject or college they should not exercise web options for the same.**
- 5) **If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the Seat allotted in 1<sup>st</sup> phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore the candidates are informed to exercise web options carefully for sliding with awareness of this fact.**
- 6) One time pass word (OTP) will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 7) Candidates are instructed to take a print out of saved options.
- 8) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their **allotment status on <https://tsmedadm.tsche.in/> website after each phase of counseling.**
- 9) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.
- 10) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above

criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically.

- 11) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 12) **If the candidate slides to other college during second phase of counseling in colleges affiliated to KNRUHS, the original certificates will be sent to the college concerned after the closure of admissions. Candidates have to get relieved from first phase joined college, obtain custodian certificate, collect fees and report to the allotted college before last date of joining. Candidates who do not join the course at the allotted college in this phase of counselings are not eligible for further phases of counselings.**
- 13) Candidates are informed that as per Hon'ble Supreme Court orders and MCC/DGHS, Ministry of Health Government of India notice no. U-12021/01/2022-MEC, dated. 12.07.2022 and in accordance with GO.Ms.No. 125 HM & FW Department, dated. 22.09.2022, admitted candidates are not permitted to withdraw from the course after second phase of counseling. Candidates are also informed that admitted candidates who have joined upto round 2 of All India quota and State Quota shall not be eligible for further rounds of All India Quota and State counsellings (Competent Authority Quota and Management Quota).
- 14) Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the second phase of counseling to get their original certificates back. **Candidates also will be debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking.**
- 15) The University fee once paid shall not be refunded under any circumstances.
