Recommendations on Statutes on Affiliation Of Colleges Of B.Sc. Allied Health Sciences Courses. Approved by the Executive Council of University.

In exercise of the powers conferred by sub-section (2) section 31 of the University of Health Sciences Act, 2014 (Act No.6 of 2014), the Executive Council of the Kaloji Narayana Rao University of Health Sciences, Warangal hereby makes the following statutes: -

- i) These statutes may be called the Statutes for Affiliation of Colleges of B.Sc. Allied Health Sciences Courses
- a. Anesthesia Technology
- b. Operation Theatre Technology
- c. Cardiac and Cardio Vascular Technology
- d. Renal Dialysis Technology
- e. Optometry.
- f. Respiratory Therapy Technology
- g. Neuro Science Technology.
- h. Critical care Technology
- i. Nuclear Medicine Technology
- j. Radio Therapy Technology.
- k. Radiology and Imaging Technology.
- 1. Audiology and Speech Therapy Technology.
- m. Medical Records Sciences

Here after called B.Sc. Allied Health Sciences Courses under KNR University of Health Sciences.

- ii) They shall come into force from the date of assent of the Chancellor.
- I. The words and phrases used in these statutes shall, unless expressly explained otherwise, have the same meaning as they have with reference to the KNR University of Health Sciences Act 2014 (UHS Act 6 of 2014) hereinafter called the Act.

It shall be necessary for the affiliated Medical College Hospitals and other major Hospitals with 300 beds strength or above having Super Specialty/Specialty departments offering recognized DM/M.Ch./MD/MS/DNB courses for starting of B.Sc. Allied Health Sciences Courses with 10 to 20 seats in each of the following subjects to apply for no objection certificate (NOC) from State Government. The institutions have to apply with NOC to the KNR University of Health Sciences, Warangal for starting 1st year Bachelor of Science in these courses of study for Affiliation of their institution with KNR University of Health Sciences, Warangal. (In accordance with G.O.Ms.No. 14, dated: 11.02.2022).

- a. Anesthesia Technology
- b. Operation Theatre Technology
- c. Cardiac and Cardio Vascular Technology
- d. Renal Dialysis Technology
- e. Optometry.
- f. Respiratory Therapy Technology.
- g. Neuro Science Technology.
- h. Critical care Technology
- i. Nuclear Medicine Technology (AERB permission required)
- j. Radio Therapy Technology.
- k. Radiology and Imaging Technology.
- 1. Audiology and Speech Therapy Technology.
- m. Medical Records Sciences.
- II. (i) Medical College Hospitals and other major Hospitals with 300 beds strength or above having Super Specialty/Specialty departments offering recognized DM/M.Ch./MD /MS/ DNB courses which satisfy the conditions stipulated hereunder in sub- statute shall be eligible for starting B.Sc. Allied Health Sciences Courses mentioned above. Application from the individuals for Certificate of Registration and affiliation will not be entertained.
 - (ii) Conditions to be satisfied by the applicant institution for applying for Certificate of Registration and affiliation for these B.Sc. Allied Health Sciences Courses are as follows.

The institution must be a Modern Medical College having an attached teaching Hospital with recognized MBBS courses and recognized PG courses or other major Hospitals with 300 beds strength or above having Super Specialty/Specialty departments offering recognized DM/M.Ch./MD /MS/ DNB courses in the related subjects (i.e., a. Anesthesia Technology b. Operation Theatre Technology c. Cardiac and Cardio Vascular Technology d. Renal Dialysis Technology, e. Optometry, f. Respiratory Therapy Technology g. Neuro Science Technology, h. Critical care Technology i. Nuclear Medicine Technology, j. Radio Therapy Technology, k. Radiology and Imaging Technology, l. Audiology and Speech Therapy Technology, m. Medical Records Sciences Technology) respectively.

The teaching hospital shall have the diagnostic facilities in above departments and in Biochemistry, Clinical Pathology and Microbiology. These departments should be headed by qualified teaching staff as prescribed by the National Medical Commission. The hospital should have facility of blood bank as per the concerned regulations.

As per the existing rules, permission from AERB is required to start the course of B. Sc. Nuclear Medicine Technology.

iii) The Hospital/College shall have the following full-fledged departments under qualified teaching staff as specified by the National Medical Commission with the following sections:

Parent Department:

All departments must have 20 bedded ward, 5 beds ICU, with following specific equipment.

a) B.Sc. Anaesthesia Technology:

The following are the requirements:

Anaesthesia Work Stations, Vaporizers, Laryngoscopes, Endotracheal Tubes, Laryngeal Mask Airways, Airways, Face masks, Multipara Monitors, Suction apparatus, Central Supply of Oxygen and Nitrous Oxide gases, Infusion pumps, Ambu bag, Bain Circuit, Crash Cart, Endoscopes, Peripheral Nerve Stimulators, USG machine, Gum elastic Bougies.

b) B.Sc. Operation Theatre Technology:

The following are the requirements:

- a) Minimum 4 Operation theaters (2-General & 2-Specialty)
- b) PACU with 6 beds (Recovery room)
- c) RICU with 6 beds
- d) Work stations 4, ABG, Monitors, defibrillators, Crash Carts,ICU ventilators -6, Central Oxygen and Suction.
- e) CSSD.

c) B.Sc. Cardiac & Cardio Vascular Technology:

The following are the requirements:

a) ECG, Echo, TEE, Treadmill, Cath lab, Holter, 10 beds ICU with all modern monitoring equipment, defibrillators.

d) B.Sc. Renal Dialysis Technology:

The following are the requirements:

- a) Hemodialysis department with 10 HD machines
- b) Peritoneal dialysis facility
- c) Renal Lab with kidney biopsy facility.

e) B.Sc. Optometry Technology:

The following are the requirements:

- a) Thin lenses, Thick Lenses, Prisms with all diopters and refractory equipment.
- b) Optical & ophthalmic instruments: Standard Test Charts, Retinoscopes, Ophthalmoscopes) direct & indirect), Refractometers, Auto Refractometers, Slit lamps, Keratometer, tonometer, devices for colour vision testing, ultra sono gram (A scan & B Scan)

f) B.Sc. Respiratory Therapy Technology:

The following are the requirements:

ECG, 2DEcho, TMT, Digital X-Ray Machine, Ventilators, Multipara monitors Defibrillators, Pulse oximeters, USG, ABG machines, Electrolytes, Creatine, Intubation sets, Holters, 10 beds each ICU, INCU, AMC, RICU, Ophthalmoscopes, Nebulizer, C-PAP Apparatus, Refrigerators, Tutorial Rooms, Staff Room. Dress Changing Rooms, Difficult intubation Carts, Crash Carts.

g) B.Sc. Neuro Science Technology:

1) B.Sc. Audiology and Speech Therapy Technology:

The following are the requirements:

Audiology: 2 channel Diagnostic Audiometer with Accessories such as earphone, ear cushion combination with adjustable headband, B.C. vibrator, transducers like microphone and matching loud speakers, Portable Audiometer with provision of A.C. and B.C. testing: desirable screening audiometer, Clinical Immittance Audiometer (Desk model) with accessories, Portable/Screening impedance, audiometer, Clinical BSEAR, Otoacoustic emission, Calibration equipment for AC, BC and free field (by possession or access), IGO and HAT for hearing aid trial and making electroacoustic measurements, Stop watch, Otoscope, Ear Mould Lab-fully equipped.

Speech Pathology: Speech and Language Tests (Tests for differential diagnosis) (English and local language), Proformae, Speech Therapy material (Indian, Language and English), Toys and Books, Mirrors - size 2' x 3, Speech Trainer, Portable and Digital tape recorders, Hi-Fi Ampli Deck with speakers and good microphone, Expirograph/Aerophone, Computer PC-AT with VGA Color Monitor, Software for diagnostic/therapeutic use, Endo stroboscope, EGG, Stop Watch, Audio cassettes for training/CDs, Pitch pipe, Tongue depressors.

m) B.Sc. Medical Records Sciences

Note: All the departments shall have infrastructure as per NMC Guidelines for intake of 100 MBBS seats.

- **9. Surgery department** as per NMC Guidelines of 100 MBBS seats intake.
- **10. Medicine** as per NMC Guidelines of 100 MBBS seats intake.

Note: All these requirements are subject to modifications as per the minimum standards for Allied Health Sciences courses to be notified by National Commission for Allied Health Sciences /State Allied and HealthCare Council at a letter date.

- IV. The application for Certificate of Registration and affiliation from the KNR University of Health Sciences, Warangal shall be in writing and in Form-I annexed with these statutes addressed to the Registrar of the KNR University of Health Sciences, Warangal and shall be submitted to the Registrar before 1st July of the Academic Year preceding to which affiliation is sought for. The inspection fee of Rs.25,000/- for each course. (Waived off for Government Medical Colleges).
- V. The application for Certificate of Registration and affiliation shall be submitted along with the Essentiality Certificate issued by Telangana State Government to establish the course and shall contain the following particulars namely.
 - a. Name of the owner Government / Trust / Society with full address;
 - b. Name of the affiliated college
 - c. Place and address where the courses are to be located
 - d. The details of courses and number of students proposed to be admitted in the first year of the course ten to twenty students per course.
 - e. The availability of the land, building and other physical infrastructure, training facility available to the students to be admitted;
 - f. Ready built-in area available for accommodation of the academic complex;
 - g. Hostels if available for boys and girls;
 - h. The applicant shall provide such other particulars as may be required by Kaloji Narayana Rao University of Health Sciences, Warangal, from time to time.
- VI. On receipt of the application for the Certificate of Registration and Affiliation, the University shall scrutinize the same and depute an Inspection Committee to verify the conditions required to be fulfilled by the applicant to become eligible to receive the said certificate of Registration and Affiliation. The Inspection Committee will consist of the faculty, preferably from Government institutions but not from the same college which is applying for the said course.
- VII. The Inspection Committee shall specifically examine whether the following conditions are fulfilled by the applicant. The proforma of Inspection Committee report to be furnished by the Inspectors shall be in Form-III annexed with these statutes.

Conditions to be fulfilled by the applicant to become eligible to receive the Certificate of Registration and Affiliation.

a. The applicant shall satisfy the criteria of the University that all the infrastructural facilities of the college are in one campus.

- b. The college should have in addition a workshop for medical instrumentation.
- c. The applicant shall own a ready built area of 15,000 sq.ft. suitable for starting the B.Sc. Allied Health Sciences Courses—with proper sanitation facilities, provision for safe drinking water, adequate water supply for clinical and laboratory purposes, library, store rooms, toilets for students, staff (separately for men and women) and such other facilities necessary and those that may be specified by the University from time to time in this regard. It is desirable to have hostel facility (separately for boys and girls).
- VIII. The applicant shall fulfil the following conditions before applying for Registration and affiliation for the 1st year B.Sc. Allied Health Sciences Courses of study, namely:
 - a. Shall have obtained Essentiality Certificate from the Government of Telangana.
 - b. Shall appoint Principal and Professor who shall be a qualified teacher in the said course
 - c. Shall submit letters for appointment of qualified staff members as detailed below, which are absolutely essential to become eligible to start the first year B.Sc. Courses of study in the said subject

d. QUALIFICATIONS OF STAFF:

i) Director & Program Coordinator:

The Director and Program Coordinator should preferably be a Professor and have MD / MS Degree with 8 years teaching experience. The Principal of the Medical College will be the Director Cum Program Coordinator.

ii) Professor:

MD / MS Degree in the said subject as per NMC Regulations.

iii) For the post of Assistant Professors:

MD Degree in the concerned Specialty.

e. The applicant shall produce evidence to the effect that the proposed college of B.Sc. Allied Health Sciences Courses is fully equipped in the following aspects:

- IX. In case there are deficiencies in the fulfillment of the conditions, the same may be informed to the concerned management. After receipt of the compliance report of the Management, the University may conduct re-inspection on payment of a sum of Rs. 10,000/- (Rupees ten thousand only) or such amount as may be prescribed by the Executive Council from time to time, by means of a Demand Draft drawn in favour of the Registrar, KNR University of Health Sciences, Warangal. The Inspection Committee shall re inspect the institutions and submit report to the University.
 - IV.When the University is fully satisfied on the basis of the Inspection report that all the conditions required by the applicant are fulfilled, the University shall notify the institutions for payment of affiliation fee of Rs.2.00 lakhs per course (waived off for Government Medical Colleges) or as fixed by the Executive Council of University from time to time in the form of DD in the name of the Registrar. The University shall issue a Certificate of Registration and Provisional Affiliation to the applicant to enable the applicant to start the first year B.Sc. Courses in the said subject mentioned above and for which affiliation is granted by the KNRUHS. The institution shall apply and obtain permission from Telangana State Allied and Health Care Council as and when the process of permission is initiated.
- V. The University shall be competent to withdraw the provisional affiliation granted herein by giving three months' notice stating the reasons thereof to the applicant.
- VI. (1) The provisional affiliation granted by the University shall be only for the first year B.Sc. Allied Health Sciences Courses of study.
 - (2) The college shall have a duly constituted Governing Body / Managing Committee with the representatives of the teaching staff, to advise the Principal in the internal affairs of the college. The Committee shall have at least one representatives of the University nominated by the Vice-Chancellor and one representative of the Government of TS from the Medical Education Department nominated by the Government. A record of the proceedings of the said Governing Body / Managing Committee shall be maintained by the Principal who shall be the Secretary to the Governing Body / Managing Committee.

The Governing Body shall have as its members not less than 6 and not more than 10 members including

- a) Director and Program Coordinator / Principal
- b) One person to be nominated by the Vice-Chancellor to represent the University.
- c) Vice Principal (Academic)
- d) One person from each subject of the teaching staff of the College concerned by election from among themselves, of which at least half are from the subjects of the B.Sc. courses and at least one is from the Medical Education Unit.
- e) One representative of the Government of TS from the Medical Education Department to be nominated by the Government
- (3) The member nominated by the University under sub-statute (2) shall hold office for a period of two years. Any change in the Governing Body of the college shall be reported to the University immediately.
- (5) The Governing Body / Managing Committee of the college shall meet at least once in three months to consider the budget estimates and such other matters as may arise in its working. It shall meet in May-June each year to consider the Annual Report, the audited statement of accounts, changes in the staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year. A copy of the notice of meeting shall be sent to the nominee of the University, with a copy to the Registrar at least 15 clear days before the date of the meeting. A copy of minutes of the meeting shall also be sent to the nominee of the University and the Registrar within fifteen days of the meeting.
- (6) The college shall periodically submit to KNRUHS and update the list of faculty members in the college in the said departments and related departments to KNRUHS once in every year.
- VII. Six months after commencement of the first year B.Sc. Allied Health Sciences Courses, the applicant shall apply to the University for affiliation of the second year B.Sc. Allied Health Sciences Courses in form III annexed with these statutes. Facilities in concerned departments with the staff members stipulated above have to be provided in the college of B.Sc. Allied Health Sciences Courses, and the details there of shall be furnished in the

said application along with the payment of inspection fee in the form of Demand Draft for Rs. 25,000/- (Rupees twenty-five thousand only) per course or such amount as may be prescribed by the Executive Council from time to time. (Waived off for Government Medical Colleges).

- VIII. On receipt of the application for affiliation for the second year B.Sc. Allied Health Sciences Course of study the University shall send its Inspection Committee at least three months before the date of commencement of the first year B.Sc. Allied Health Sciences Course examinations.
 - IX. The Inspection Committee sent by the University shall inspect the facilities available in the college and report to the University as to whether all the facilities required to be provided by the college are actually provided. In case there are deficiencies in the fulfillment of the conditions, the same may be informed to the concerned management. After receipt of the compliance report of the Management, the University may conduct reinspection on payment of a sum of Rs. 10,000/- (Rupees ten thousand only) or such amount as may be prescribed by the Executive Council from time to time, by means of a Demand Draft drawn in favour of the Registrar, KNR University of Health Sciences, Warangal. The Inspection Committee shall reinspect the institutions and submit report to the University
 - X. After a detailed examination of the final report of the Inspection Committee, when the University is fully satisfied that all the conditions required by the applicant are fulfilled, the University shall notify the institutions for payment of affiliation fee of Rs.2.00 lakhs per course (waived off for Government Medical Colleges) or as fixed by the Executive Council of University from time to time in the form of DD in the name of the Registrar for second year. The University shall grant provisional affiliation for the second year B.Sc. course of study in the said subject mentioned above and for which affiliation was granted by the KNRUHS to start the course.
 - XI. It shall be competent for the University to withdraw the provisional affiliation granted herein by giving three months' notice stating the reasons therefore to the applicant.
- XII. The provisional affiliation granted by the University as specified in statute 17 shall be only for the second year B.Sc. Allied Health Sciences Degree Course of study.
- XIII. Six months after commencement of the second year B.Sc. Allied Health Sciences Courses, the applicant shall apply to the University for affiliation of the third year B.Sc. Allied Health Sciences Courses in form III annexed with these statutes. Facilities in concerned departments with the staff members stipulated above have to be provided in the college of B.Sc. Allied Health Sciences Courses, and the details there of shall be furnished in the said application along with the payment of inspection fee in the form of Demand Draft for Rs. 25,000/- (Rupees twenty-five thousand only) per course or such amount as may be prescribed by the Executive Council from time to time. (Waived off for Government Medical Colleges).
- XIV. On receipt of the application for affiliation for the third year B.Sc. Allied Health Sciences Course of study the University shall send its Inspection Committee at least three months before the date of commencement of the second year B.Sc. Allied Health Sciences Course examinations.
- XV. The Inspection Committee sent by the University shall inspect the facilities available in the college and report to the University as to whether all the facilities required to be provided by the college are actually provided. In case there are deficiencies in the fulfillment of the conditions, the same may be informed to the concerned management. After receipt of the compliance report of the Management, the University may conduct reinspection on payment of a sum of Rs. 10,000/- (Rupees ten thousand only) or such amount as may be prescribed by the Executive Council from time to time, by means of a Demand Draft drawn in favour of the Registrar, KNR University of Health Sciences, Warangal. The Inspection Committee shall re inspect the institutions and submit report to the University
- XVI. After a detailed examination of the final report of the Inspection Committee, when the University is fully satisfied that all the conditions required by the applicant are fulfilled, the University shall notify the institutions for payment of affiliation fee of Rs.2.00 lakhs per course (waived off for Government Medical Colleges) or as fixed by the Executive Council of University in the form of DD in the name of the Registrar for third year. The

University shall grant provisional affiliation for the third and final year B.Sc. course of study in the said subject mentioned above and for which affiliation was granted by the KNRUHS for second year. It shall be competent for the University to withdraw the provisional affiliation granted herein by giving three months' notice stating the reasons therefore to the applicant.

- XVII. The University shall be competent to inspect the college at least once in three years to ensure whether the quality of service, teaching and research are properly maintained.
- XVIII. The University shall also be competent to send observers during examinations at their discretion.
 - XIX. The applicant shall send to the University every year a report regarding the service academic and research activities of the college, and also annual staff return and vacancy position.
 - XX. On the completion of the course of study by the first batch of students, the applicant may make an application to the University for the grant of permanent affiliation of B.Sc. Allied Health Sciences Course of Study in the prescribed form IV annexed with these Statutes, paying an inspection fee of Rs.25,000/- per course (Rupees twenty-five thousand only). The University, after satisfying itself as to the performance of the college during the previous years and subject to the statutes and procedures in force from time to time, shall grant permanent affiliation to the B.Sc. Allied Health Sciences Courses Degree Course of Study.

It will be renewed on verification, for every five years duly following the procedure prescribed above.

However, the management shall continue to pay affiliation fee of Rs. 2,00,000/- (Two Lakhs) per course to the University every year or an amount as prescribed by the Executive Council from time to time.

- XXI. The Executive Council shall have the power after due enquiry to withdraw affiliation granted to a college, provided that before coming to such a decision, the Executive Council shall inform the Governing Body / Managing Committee of the college concerned of its findings after enquiry and shall allow it an opportunity of making such representation as it may deem fit and shall record its opinion on this representation so made.
- XXII. It shall be competent for the University to send an Inspection Committee at any time to inspect the College of B.Sc. Allied Health Sciences Courses after two weeks' notice to the applicant and on receipt of report from the Inspectors, the University may make any decision whichin its opinion deems fit and necessary.
- XXIII. Affiliated institution shall apply to the University for starting of Postgraduate Courses only after three years of establishment of the institution / college and it has been granted permanent affiliation.
- XXIV. In case of the institution controlled by Government / KNR University of Health Sciences application of statute 9 (a) (b) (c) shall be decided by the Executive Council on the basis of merit. Government also shall sanction affiliation fee to be paid to the University.
- XXV. The general statutes on affiliation which are not covered in this special statute on affiliation of colleges of B.Sc. Allied Health Sciences Courses shall be binding in addition to the above statutes.
