NOTIFICATION FOR REGISTRATION FOR ADMISSION INTO MBBS/BDSCOURSES OF MANAGEMENT QUOTA FOR 2022-23 STRAY VACANCY PHASE

In continuation to this office notifications dated 19.10.2022, 07.11.2022, 10.11.2022, 30-11-2022 &12-12-2022 Kaloji Narayana Rao University of Health Sciences hereby notifies registration for admission into MBBS/BDS courses under Management Quota for Stray Vacancy Phase from eligible candidates who have not registered in response to the earlier notification issued for online registration.

This notification is issued in consideration of representations from candidates and un allotted vacant seats under Management Quota in MBBS and BDS courses and in accordance with the Government Memo providing for one time relaxation of relevant provisions issued in G.O.Ms.No.126 and 127 HM&FW (Cl) Dept Dated: 22.09.2022as per rule 4 (i) ("No fresh registrations are permitted after the last date of the online registration as notified by the university".)

Candidates who have secured the following cutoff scores or above in NEET UG- 2022 are eligible to apply.

Category	Qualifying Criteria	Cut offscore
General Category including EWS	50 th Percentile	117
SC/ST/BC &PWD Candidates of SC/ST/BC Category. (only for eligibility)	40 th Percentile	93
Persons with Disability (OC) (only for eligibility)	45 th Percentile	105

Candidates willing for registration shall attend in person along with parent/guardian at the Helpline center, Directorate of Admissions, Kakatiya University Campus, Hanamkonda on 17.12.2022 between 9.00 AM and 4.00 PM.

IMPORTANT INFORMATION TO CANDIDATES:

Registration shall be processed subject to fulfillment of following conditions to prevent seat blocking in Stray Vacancy Phase of counseling:

- 1. Candidate shall submit all the original certificates as notified in ANNEXURE-I.
- Candidate shall submit Demand Draft for Rs.6300/- (Rupees Six thousand Three Hundred only) towards Registration Fee and Verification fee in favor of Registrar, KNRUHS payable at Warangal.
- Candidate shall submit Demand Draft towards Tuition fee in favor of Registrar, KNRUHS payable at Warangal

For MBBS course.

- a. Rs.13,00,000 (Rupees Thirteen lakhs only) for registration under B Category
- Rs.26,00,000 (Rupees Twenty Six lakhs only) for registration under C/NRI Category

(The difference of Tuition fee, if any shall be adjusted at the allotted college)

For BDS Course.

Demand Draft of Rs.2,00,000 (Rupees Two lakhs only) for B and C/NRI Category.

(The remaining Tuition fee shall be paid by the candidate at the allotted college.)

- 4. An undertaking as detailed in ANNEXURE II.
- 5. Candidates are hereby informed that if a seat is allotted in the counseling, Tuition fee and Original Certificates shall be transferred to the allotted college. If no allotment is made Tuition fee and Original Certificates shall be returned to the candidates after the closure of admissions.

Registered Candidates shall be included in the merit list as per their NEET UG -2022 rank.

KNRUHS will issue notification of schedule for exercising web-options for Management Quota on the website. Candidates are directed to check the website regularly. No individual intimations shall be sent.

Candidate shall exercise web-options for vacant seats as per their eligibility and

registration for course and category.

orders of Rules for admissions and earlier Management Quota notifications displayed

on KNRUHS website.

Allotment of seats shall be made in accordance with Government orders,

University Regulations and Hon'ble Supreme Court/High Court orders.

IMPORTANT NOTE: Candidates are hereby informed that if they are

allotted a seat as per their options and if they do not join course at allotted

college, the tuition fee deposited shall be forfeited and penalty clause as notified

in the G.O.Ms.No.126 and 127 HM&FW (Cl) Dept Dated: 22.09.2022 shall be

applicable.

with clause notified in the above GO's.
