#### PROSPECTUS FOR ADMISSIONS INTO M.D.(UNANI) COURSES – 2022-23

- 1. The following are the Regulations for admission into M.D. (UNANI) in Govt. Nizamia Tibbi College, Hyderabad, affiliated to KNR University of Health Sciences, Telangana, Warangal for the academic year 2022-23.
- 2. <u>NUMBER OF SEATS</u>: No. of seats permitted and available for admission for the academic year 2022-23 after excluding the seats contributed to All India Quota will be notified through KNRUHS website separately

#### 3. ELIGIBILITY FOR ADMISSION:

- 3.1. Candidates who have appeared AIAPGET 2022 and whose names are included in the merit list of AIAPGET-2022 for Unani P.G. are only eligible to apply, subject to fulfillment of regulations, Candidate should secure the following minimum eligibility percentile or above.
  - a) 50% for General Category (Open) candidates.
  - b) 45% for General Category (Persons with Disabilities (OC-PWD)) candidates.
  - c) 40% for SC, ST and other Backward class including Persons with Disabilities
- 3.2 The PG Courses leading to Doctor of Medicine in Unani are open to the holders of a Degree obtained after undergoing a regular institutional course of study in Unani both Theory and Practical of not less than four years duration of a University established in India by a state, provincial or Central Act or of an Institution or Board recognized by the University Grants Commission or by a State Government or incorporated under a Central or a State Act.
- 3.3 The candidate should have completed internship by 31-12-2022.
- 3.4 For in-service candidates, three years of regular service shall be calculated as on 31-07-2022. The in-service seats subject to the rules and regulations of Government of Telangana. The admissions into in-service seats will be considered subject to availability of in service seats and deputation orders issued by Government of Telangana.
- 3.5 "Candidates who are already admitted and studying MD (UNANI) Course shall not be permitted for counseling unless they discontinue the course by remitting the bond amount and the stipend taken upto that date before submitting application form and such candidates shall submit the discontinuance certificate issued by the Head of the Institution along with the application.

- 3.6 Candidates who are already holding a Post Graduate Degree in Unani in a subject shall not be eligible for admission into another P.G. Unani Course.
- 3.7 Regarding seats of Central Government Nomination (CGN), Revised Guidelines shall be applicable communicated by Govt. of India vide Letter F.No.R.12013/02/2014-E&C(PG) dt.17-07-2014.

#### 4. RESERVATIONS:

- 4.1 15%, 10% and 29% of the seats available in each course shall be reserved for SC, ST and BC categories respectively under Competent Authority Quota.
- 4.2 A candidate claiming reservation under clause 4.1 shall produce a certificate of his / her social status in the form specified and appended as Annexure II to the application. Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to castes which are notified in the list as per the Telangana Government orders will be considered against the respective reserved seats.
- 4.3 The seats reserved for the SCs shall be made available to the STs and vice-versa, if qualified candidates are not available in these categories, the seats reserved for both SCs and STs shall be made available to the candidates in general pool, if qualified candidates belonging to the SCs and STs are not available.
- 4.4 15% of seats in clinical subjects and 30 % of seats in non-clinical subjects are reserved for in service candidates in each category. Candidates selected on merit in the respective categories shall be counted against in service quota. Candidates working on contract basis, consolidated pay basis, daily honorarium and adhoc basis are not considered as regular service candidates.

Explanation: An in-service candidate is one who has put in a minimum of three years of regular service as certified by Director of AYUSH Telangana.

#### 4.5. Reservation for Persons with Disabilities category (PWD):

5% of seats in each specialty course wise are reserved for Persons with Disabilities category candidates. (PWD Quota reservation will be followed if sufficient number of seats are available for each course under each category).

#### **4.6 EWS reservation:**

Will be implemented as per the seats sanctioned by Government.

4.7 The number of seats reserved to various categories are as follows as per G.O.Ms.No.603, HM & FW (R2) Dept., dt.28-12-2004 and after making provision for 3 seats in Advia course for Government of India Nominees as per G O I Letter No.R.12013/1/2003-E&C (i), dt.23-3-2004 and 1 seat each in Moalijat and Qabalat-O-Amraz-e-Niswan courses for foreign nationals as per G O I Letter No.R.12013/1/2003-E&C (ii), dt.23-3-2004.

#### 5. RESERVATION IN FAVOUR OF LOCAL CANDIDATES:

Admission to 85% of the seats specified in Regulation 2 above shall be reserved in favour of and allocated among the local candidates in relation to the local area in respect of the Andhra University including the Nagarjuna University area, the Osmania University including the Kakatiya University area and S.V.University including the Sri Krishna Devaraya University area in the ratio of 42:36:22 respectively. While determining the number of seats to be reserved in favour of local candidates, in respect of local area any fraction of 0.5 and above shall be counted as one provided that there shall be at least one unreserved seat.

#### 6. LOCAL AREA:

- 6.1 The part of the State comprising the Districts of Adialabad, Hyderabad (including the twin cities of Hyderabad and Secunderabad), Rangareddy.Karimnagar, Khammam, Medak, Mahaboobnagar, Nalgonda, Nizamabad and Warangal shall be regarded as the local area in respect of the Osmania University and the Kakatiya University.
- 6.2 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the local area in respect of the Andhra University and the Nagarjuna University.
- 6.3 The part of the State comprising the Districts of Anantapur, Kurnool, Chittoor, Kadapa and Nellore shall be regarded as local area in respect of S.V. University and Sri Krishna Devaraya University.

#### 7. LOCAL CANDIDATES:

- 7.1 A candidate for admission to any course of study shall be regarded as local candidate in relation to a local area
- 7.1.1 If he/ she has studied in an educational institution(s) in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in the relevant qualifying examination or
- 7.1.2 Where, during the whole or any part of the four consecutive academic years ending with the academic year in which he / she appeared or, as the case may be first appeared for the relevant qualifying examination, if he/she has not studied in any educational institution, if he / she has resided in that local area for a period of not less than four years immediately preceding the commencement of the relevant qualifying examination in which he/she appeared or as the case may be first appeared.

- 7.2 A candidate for admission to any course of study who is not regarded as a local candidate under sub-regulation 6.1 above in relation to any local area shall:
- 7.2.1 If he/ she has studied in an educational institution in the state for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as a local candidate in relation to:

Such local area where he / she has studied for the maximum period out of the said period of seven years

or

Where the period of his / her study in two or more local areas are equal, such local area where he / she studied last in such equal periods; or

- 7.2.2 If during the whole or any part of the seven consecutive academic years ending with the academic year in which he/she appeared or, as the case may be, first appeared for the relevant qualifying examination he/she had not studied in the educational institutions in any local area, but has resided in the state during the whole of said period of seven years, be regarded as a local candidate in relation to:
  - i) Such local area where he / she has resided for the maximum period out of the said period of seven years; or
  - ii) Where the periods of his / her residence in two or more local areas are equal, such local area where he / she resided last in such equal periods.

#### **EXPLANATIONS**: For the purpose of this regulation:

- i) "Educational Institutions" means a University or any educational institution recognized as such by the State Government, a University or other authority competent in that behalf:
- ii) "Relevant qualifying examination" in relation to admission to any course of study, means the examination, a pass in which the minimum educational qualification for admission to such course of study.
  - NOTE: The relevant qualifying examination for admission to Doctor of Medicine (Unani) being Bachelor of Unani Medicine and Surgery examination, the question whether a candidate is a local candidate or not shall be determined with reference to his / her first appearance in the Bachelor of Unani Medicine and Surgery examination.
- a) In reckoning the consecutive academic years during which a candidate has studied any period of interruption of his/her study by reasons of his/her failure to pass any examination shall be disregarded;

- b) Any period of his/her study in a State-wide University or a State-wide educational institution shall be disregarded
- iv) The question whether any candidate for admission to any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his / her parent or guardian.
- 7.3 If a local candidate in respect of a local area is not available to fill up any seat reserved or allotted if favour of local candidate in respect of that local area, such seat shall be filled as if it had not been reserved.

## 8. The following categories of candidates are eligible to apply for admission to the 15% of unreserved seats.

- 8.1 All candidates defined under Regulation 7.
- 8.2 Candidates, who have resided in the State for total period of ten years excluding periods of study outside the state, or either whose parents have resided in the State for a total period of ten years excluding periods of employment outside the state.
- 8.3 Candidates whose parents are in the employment of this state or Central Government,
  Public Sector Corporations, local bodies. Universities and other similar quasi public institutions within the state.
- 8.4 Candidates who are spouses of those in employment of this State or Central Government, Public Sector Corporations, local bodies, Universities and educational institutions recognized by the Government, a University or other competent authority and similar other quasi government institutions within the State.
- 8.5 Candidates who are employees in the State Government undertakings, public sector corporation, local bodies, Universities and other similar quasi public institutions within the State.
- 8.6 Candidates who are the spouses of the local candidates as per Regulation 8.1.4.
- Note: Relevant certificates shall be enclosed to the applications in respect of their claim, in respect of residence. The certificates should be from the revenue authorities not below the rank of a Mandal Revenue Officer.

#### 9. ELIGIBILITY FOR ADMISSION:

9.1 The PG Courses leading to Doctor of Medicine in Unani are open to the holders of BUMS Degree of any University/Statutory body included in the 2nd schedule to the IMCC Act, 1970.

- 9.2 The candidate should have completed training as internee/House Officer.
- 9.3 For in service candidates three years of regular service shall be calculated as on 31-07-2022.
- 9.4 Candidates who are already admitted and studying MD (Unani) Course shall not be permitted for counseling unless they discontinue the course by remitting the bond amount and the stipend taken upto that date before submitting application form and such candidates shall submit the discontinuance certificate issued by the Head of the Institution along with the application.
- 9.5 Candidates who are already holding a Post Graduate Degree in Unani in a subject shall not be eligible for admission into another P.G. Unani Course.
- 9.6 Regarding seats of Central Government Nomination (CGN), Revised Guidelines shall be applicable communicated by Govt. of India vide Letter F.No.R.12013/02/2014-E&C(PG) dt.17-07-2014.

- 10.3 After completing the data entry in all pages of the online application and after submitting the data through online, the candidate should take the print-out of the filled-in online application form. The Candidate should note the Barcode application number which appears on the printout of application for future reference.
- 10.4 The candidate should paste a recent passport size photograph in the space provided in the print out of online application form. The Photo should be attested by Gazetted Officer/ Principal of the College (identical to the photo that used for scanning)

#### 10.5 **Registration and Processing Fee:**

The registration and Processing fee is Rs. 4,000/- (Bank transaction charges extra) for OC/BC categories and Rs.3,000/- (Bank transaction charges extra) for SC/ST categories. For GOI Nominee candidates - Rs.4000 + Bank charges

<u>Verification Fee for Equivalency</u>: The candidates who acquired their Under Graduate Degree outside the State of Telangana /Andhra Pradesh or Country/Abroad and got their certificates registered with Council and applying for admission under this University, shall pay a verification fee of Rs.5,000/- for degree certificates acquired Abroad and Rs.3,000/- for the degrees acquired outside the State.

- 10.6 The candidate should sign at the declaration area in the print out of the online application form and also put left hand thumb impression at the space provided without fail.
- 10.7. The candidate should submit the print-out of the filled-in online application along with the self attested copies of required certificates at the time of certificate verification and counseling at Help line center as notified by the University.

#### 11. The following shall be enclosed along with print out of on-line application form:

Note: In case candidates passed BUMS Course from state-wide institutions i.e. Government Nizamia Tibbi College, Hyderabad they shall enclose the study certificates from VI to Intermediate.

#### 12. VERIFICATION OF ORIGINAL CERTIFICATES.

The University will notify the schedule for counseling for which includes verification of Original Certificates of candidates and exercising options by the candidates.

#### 13. MERIT LIST:

Merit position of candidates shall be determined based on percentile and rank obtained in AIAPGET-2022. (Unani)

#### 14. **SELECTIONS**:

- 14.1 Provisional Selection shall be made by the Selection Committee constituted by the University.
- 14.2 The Selection Committee shall provisionally select the candidates as per these regulations from among the candidates who qualified AIAPGET 2022 as per merit list.
- 14.3 The candidates shall produce their original certificates for verification and after verification if eligible, candidates shall exercise options for the courses they are interested to join in order of priority. Candidates are permitted to exercise one time options only irrespective of number of phases of counseling.
- 14.4 The candidates shall be called to appear for verification of original certificates one after another and they shall not enter the selection committee room in groups. Any person who obstructs the proceedings of the Selection Committee or otherwise misbehaves or causes disturbance at the selection committee meeting will be liable for disciplinary action as may be taken by the University.
- 14.5 The candidates shall submit their option for subjects of his / her choice in order of priority to Selection Committee. The Selection Committee will select the candidates as per the Admissions Regulations and Government Rules from among the eligible candidates after verification of original certificates and who have submitted their options. The list of provisionally selected candidates will be displayed and the provisional selection intimations will be issued to the selected candidates.

- 14.6 The Selection Committee shall have power to review the provisional selection in case of any errors, misrepresentation, fraud or glaring injustice. In all matters relating to selections and admissions, the decision of the selection committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.
- 14.7 If a candidate after choosing the subject fails to pay fees or fails to submit the bond, his/her selection stands cancelled automatically. If a candidate is absent for verification of original certificates and exercising options, he/she will not be considered for selection at the subsequent selection in the then available courses.

#### 15. <u>CONDITIONS OF ADMISSION</u>:

- 15.1 The Principal, Govt. Nizamia Tibia, Unani Medical College, Hyderabad shall verify the correctness of documents. On his satisfaction he shall direct the candidates to credit the college fee etc., immediately.
- 15.2 Candidates joining courses shall execute a bond on non judicial stamp paper of value of Rs.100/- in the form specified in Annexure-I to ensure completion of the prescribed period of training or in default or for any other reason has to pay Rs.1,00,000/- to the Registrar, KNR University of Health Sciences and shall refund the stipend received upto that date to Government.
- 15.3 The Original certificates submitted shall not be returned to the candidates till they complete their course.
- 15.4 Candidates selected to various courses shall be whole time students. Service Candidates will have to apply for study leave and are required to produce the orders wherein such leave has been sanctioned to them from the competent authority within 3 months after joining the course.

#### **16. FEES:**

- 16.1 All the selected candidates are required to pay the admission fee, tuition fees, deposits etc., as per rules in force.
- 16.2 Tuition Fee: All the candidates selected are required to pay the tuition fee as prescribed by the Government. If any of the candidate who joined in a course is allotted to another course, the tuition fee paid by the candidate will be adjusted to the newly selected course and the tuition fee paid already shall not be refunded under any circumstances.
- 16.3. All the selected candidates shall pay the following fee in the form of crossed Demand Draft drawn on ANY NATIONALISED BANK in favour of Registrar,

KNR University of Health Sciences payable at Warangal on the day of selection.

The fee once paid shall not be refunded under any circumstances.

#### 17. ATTENDANCE AND LEAVE:

- 17.1 The post graduate students shall complete eighty five percent of attendance in all subjects separately before they appear for final examination.
- 17.2 Leave: The Post Graduates are eligible for 30 days leave in the academic year and they can avail a maximum 10 days at a time. If they avail more than 10 days at a time, the stipend shall be deducted proportionately. The balance of leave in a year if any shall not be carried forward to the next academic year.
- 17.3 Maternity leave: Post Graduate students are eligible for maternity leave as per Government rules and the period of study shall be extended accordingly.

## 17.4 <u>SANCTION OF LEAVE OF ABSENCE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP:</u>

18. Break of study and re-admission: If a student absents continuously for a period of 91 days or more and less than one year and seeks permission to attend the course, his / her application in prescribed format by paying requisite fee in favour of Registrar, KNR University of Health Sciences payable at Warangal shall be forwarded to the Registrar, KNR University of Health Sciences with the recommendation of the Principal. Regulations for re-admission after break of study along with application format and fee payable is available in the University. The candidates are advised to refer the regulatory conditions, they may submit applications through the Principal of the College by paying the fee. Candidates who discontinue the course for more than one year are not eligible for re-admission

#### 19. PRIVATE PRACTICE:

No PG student shall do any private practice or consultation practice and shall not accept any part-time employment during his/her Post Graduation.

#### **20. COLLEGE REGULATIONS:**

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University and they shall not make any correspondence with higher authorities directly without prior permission of the Professor of the concerned unit and Principal.

#### 21. STIPENDS:

- 21.1 Stipends may be paid by the Principal as per the orders of Government of Telangana to the PG students who are regular in attendance and show good progress every month in their academic pursuits. The total period during which the stipends may be paid to the students shall not exceed thirty six months for the course. No candidate will be eligible to draw the stipend for more than 36 months during the entire PG study period.
- 21.2 Service candidates shall not be paid stipend if they draw leave salary or salary.

#### 22. COMMENCEMENT OF THE COURSE:

The course shall normally commence as per the date mentioned in the schedule at last page. The duration of the course shall be calculated from this date of commencement of the course and shall be uniform for all the candidates irrespective of their individual dates of admission.

#### 23. CLOSURE OF ADMISSIONS:

Admissions shall be closed as per the date specified in the schedule notified by CCIM. Any vacancy as on the day of closure of admissions or that arises after closure of admissions shall not be filled up.

#### 24. DURATION OF COURSE AND MAXIMUM PERIOD FOR COMPLETION OF THE COURSE:

The period of training of Doctor of Medicine in Ayurveda shall be of 3 years duration in the department concerned. Candidate should complete the course within the duration equivalent to double the period of course of study. i.e.,: 6 years

#### 25. MEDIUM OF INSTRUCTION:

English shall be the medium of instruction and examination.

#### **26. POWERS OF THE PRINCIPAL:**

Notwithstanding anything contained in these regulations, the Principal, Govt. Nizamia Tibbi College, Hyderabad may at any time before completion of the PG course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and or a personal hearing, order the cancellation of admission to the PG course if in his opinion such candidates had furnished false or incorrect information in the application form or in the documents attached, certificates enclosed there to or in the statements made either before the authority incharge of admissions or the Principal or in any other fraudulent manner, obtained admission into such course. Against any such order of the Principal an appeal shall lie to the KNR University of Health Sciences, Telangana, Warangal.

## 27. POWER TO AMEND REGULATIONS AND REVIEW SELECTION OR ADMISSION OF CANDIDATES:

- 27.1 The KNR University of Health Sciences shall have the power to add or to delete or amend or alter these regulations from time to time.
- 27.2 The University may either suomoto or on an application made to them, call for and examine records relating to any selection or admission or cancellation thereof made by the authority in charge of selection or admission for the purpose of satisfying themselves as to the legality or regularity of such selection or admission orders in relation thereto, as they deem fit including cancellation of the selections already published or admissions already made provided that the University may before cancelling such selection or admission give an opportunity to the authority in charge of selection or admission and to the person effected to show cause against such cancellation.

#### 28. FINALITY OF SELECTION:

All selections under these Regulations shall be subject to any general regulations or order that may be made by University from time to time.

**29. MIGRATION /TRANSFER:** No Transfers during the course period are permitted from one college to another college under any circumstances.
