This Notification is issued for registration of the candidates to appear for **Medical PG Degree (MD/MS)** theory examinations commencing from **02.01.2025**.

## ELIGIBILITY TO APPEAR FOR PG DEGREE (MD/MS) EXAMINATIONS. JANUARY 2025:

- The PG Degree students who are admitted into the Medical Colleges of Telangana State, whose admissions are approved by the KNRUHS during the academic year 2021-22 and also the backlog students who have failed, detained and not registered for the said exams conducted earlier, who have completed three years of study period (36 months) including period of examinations are eligible to appear for the PG Degree Examinations in January 2025. A student with 80 per cent attendance of working days (i.e. 751 days of 939 days) is eligible for appearing in the examination. However, period of training will be extended by the same number of days for which maternity/paternity leave and total excess casual leave have been availed in three years.
- Also, the PG Degree students who are admitted into the Medical Colleges of Telangana State, whose admissions are approved by the KNRUHS with one year exemption of study period during the academic year 2022-23 (students with PG Diploma) and who have completed two years of study period (24 months) including period of examinations are eligible to appear for the PG Degree Examinations in January 2025. A student with 80 per cent attendance of working days (i.e. 501 days of 730 days) is eligible for appearing in the examination. However, period of training will be extended by the same number of days for which maternity/paternity leave and total excess casual leave have been availed in two years.

- The principal concerned should submit study period completion certificate of the students.
- The Cut-off date for calculation of attendance percentage of the candidates is up to 01.12.2024.
- The uploading of attendance percentage of the candidates is from 04.12.2024 to 06.12.2024.
- > The confirmation date for uploaded attendance of the candidates is on **09.12.2024**.
- A post-graduate student of a degree course in broad specialty/super specialty will do at least one of the following to make him/her eligible to appear in his/her final examination:
  - a. Poster presentation at a National/Zonal/State conference of his/her speciality;
  - b. Podium presentation at a National/Zonal/State conference of his/her speciality;
  - c. Have one research paper published/accepted for publication in journal of his/her speciality as first author
- All post-graduate students shall complete an online course in Research Methodology. The above certification shall be a mandatory requirement to be eligible to appear for the final examination of the respective post-graduate course.
- All post-graduate students shall complete course in ethics. No post-graduate student shall be permitted to appear in the examination without the certification.
- All post-graduate students shall complete a course in Basic Cardiac Life Support (BCLS) and Advanced Cardiac Life Support (ACLS) skills to be conducted by the institution. No post-graduate student shall be permitted to appear in the examination without the certification.
- Satisfactory completion of the District Residency is an essential condition before the candidate is allowed to appear in the final examination of the respective post-graduate course.

# **Digital Valuation and Providing only single answer booklet without additional** <u>answer booklet:</u>

The University is a Digital campus and implementing digital valuation for all courses. For P.G. Degree Course, a single answer booklet with candidate specific bar code on each page will

be issued to the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.

### Valuation:

All the answer scripts shall be subjected for two valuations by the University. The average of the total marks awarded by the two valuators for the paper, which is rounded off to the nearest integer (whole number), shall be considered for computation of the results. All the answer scripts, where the difference between two valuations is 15% and more of the total marks prescribed for the paper, shall be subjected to third valuation. The average of the best two total marks, awarded by the three evaluators for the paper, rounded off to the nearest integer (whole number), shall be considered for final computation of the results.

- As per NMC Regulations, the candidate shall secure not less than 50% marks in each head of passing which shall include:
  - 1) Theory aggregate 50% (In addition, in each Theory paper, a candidate has to secure minimum of 40%)
  - 2) Practical/Clinical and Viva voce aggregate 50%

Hence, the minimum pass marks in theory are as follows:

- a) 40% marks in each paper separately i.e., 40/100 (Forty out of Hundred)
- b) 50% marks cumulatively in all the four papers of theory exam i.e., 200/400. (Two Hundred out of Four Hundred)
- No grace mark is permitted in post-graduate examination either for theory or for practical.
