## **MDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2025-26**

## NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR FIRST PHASE OF COUNSELLING

In continuation to this office notifications dated: 26-06-2025, KNRUHS hereby notifies to conduct the 1st phase of web- based counseling for allotment of seats for admission into MDS courses for 2025-26 under Competent Authority Quota into affiliated Government and Non-minority Dental colleges of Telangana State.

Candidates (non service and service) whose certificates were uploaded at the time of online registration and provisionally verified by staff of concerned departments and whose names are notified as eligible candidates in the final merit list of MDS Admissions on the KNRUHS website are eligible to exercise web - options through online from computer with internet connection.

### SCHEDULE FOR EXERCISING WEB OPTIONS:

All the eligible candidates whose names are displayed in the final merit list on 07.07.2025 on KNRUHS website can exercise web options as per eligibility for admission into MDS courses from **04.00 P.M. on 07-07-2025 up to 02.00 P.M. on 09-07-2025** through <u>https://tsmds.tsche.in/</u>

For eligibility criteria and regulations refer to notification dated: 26-06-2025.

### **SEAT MATRIX:**

The details of seats (seat matrix) speciality wise in all Dental Colleges affiliated to KNRUHS are placed in the website <u>http://knruhs.telangana.gov.in</u> The allotment of seats will be made in accordance with the existing Government orders and relevant Hon'ble Supreme Court and Hon'ble High Court orders.

- All eligible NEET-PG- MDS 2025 qualified candidates as per final merit list can exercise web options for Post Graduate MDS seats in all affiliated Dental colleges as per their interest and priority.
- 2) Eligible Service Candidates whose names are displayed in the final merit list of PG MDS Admissions on KNURHS web-site after weightage of marks can also exercise web options.
- 3) Candidates are advised to go through the Prospectus and Regulations for MDS Course of KNRUHS for the AY 2025-26 under CQ, available on website before exercising web options.
- 4) Candidates exercising web options for MDS courses are informed that, there is no limit of choices (number) for exercising web-options, candidates can exercise options for any number/all specialities and colleges the candidate is interested to join as per their eligibility.
- 5) Candidates are advised to exercise web options for MDS seats in all courses and colleges in which they are interested to join. If they are not interested to join in any speciality or college then they should not exercise options for the same.
- 6) Candidates in the merit list are informed that if they do not exercise web options in the first phase of counseling, they are not eligible to exercise web options in subsequent phases of counseling to prevent seat blocking.
- 7) Important Note: Candidates are informed that if they exercise web- options for a seat and allotted a MDS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, they will not be eligible for exercising web- options for subsequent rounds of counseling.
- 8) Candidates can exercise web options through a computer having internet facility. Don't use Mobiles and Tabs for exercising web options.
- 9) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letters code with English capitals A to Z (For details, read instructions to the candidates before giving options).
- 10) Candidates are instructed to take a print out of saved options

- Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on website.
- 12) The selected candidates shall download the allotment order from the website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of allotted college on or before the last date specified in the allotment order.
- 13) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college by the admission committee. In case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
- 14) Selected candidates have to report at the respective colleges before the last date for joining as specified on the allotment order and submit all original certificates, relevant bonds and pay the tuition fee / college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within the specified date, the admission will be cancelled automatically and the candidate will not be permitted to exercise web options for subsequent rounds to prevent seat blocking.
- **15)** Original certificates will not be returned to the admitted candidate, unless the candidate discontinues the course before second phase of counseling
- **16)** The University fee and other fees once paid shall not be refunded under any circumstances.
